_____ I understand that Camp Holiday Barn is an open-play environment and because of this there are some risks. Although all dogs are supervised during play, and despite all dogs participating appearing healthy and being handled with reasonable care, dogs are not always predictable. The following may result:

1. Transfer of a communicable illness such as, but not limited to, "canine cough", also known as the Bordatella virus (even with proper vaccination), "puppy warts" also known as canine papilloma virus, or parasites.
2. Injuries, usually benign, such as broken nails, sore pads, puncture wounds, abrasions and cuts.

_____ I understand that I should not bring my dog if they are showing signs of illness such as, but not limited to nasal and/or eye discharge, ear infections (while not contagious, it can be very uncomfortable and may cause behavioral problems), coughing and/or sneezing, limping (if not normal for your dog).

_____ I understand that it is my responsibility to provide current vaccination records before my dog can be admitted to day camp. Vaccinations must be administered at least 5 days before attending.

_____ I understand that for the safety of all our guests and staffing purposes, Holiday Barn requests 24 hours notice for appointments if possible. We do offer pre-set appointments if you plan to attend on a regular basis on those certain days.

_____ If health problems develop with my dog(s), that these will be treated as deemed best by the staff of Holiday Barn with their sole discretion, and I assume full financial responsibility for any and all expenses.

_____ Photographs or other graphic, sound, or other images may be made of my dog(s) by Holiday Barn and may be used for any purpose without compensation.

Release and Agreement to Hold Harmless

The undersigned dog owner (the "Owner") understands that the participation by Owner's dog(s) in dog daycare at Holiday Barn, Ltd., a Virginia corporation, t/a Camp Holiday Barn, is not without some risk. Despite all the participating dogs appearing healthy and being handled with reasonable care, dogs are not always predictable. Owner acknowledges the risks and hereby releases Camp Holiday Barn, its employees, owners and/or agents from any and all negligence claims for any injury or damage to Owner's dog(s) resulting from the action of any other dog occurring on the property of Camp Holiday Barn and the areas adjacent thereto. Owner further agrees to pay any veterinary/medical expenses incurred as a result of injury to Owner's dog(s) or caused by Owner's dog(s) to another dog, arising out of any confrontation or other action among dogs while in the care of Camp Holiday Barn. Owner hereby gives Camp Holiday barn permission to seek veterinary care for the Owner's dog(s), at the Owner's expense, by the veterinarian of its choice. Owner will not seek to hold Camp Holiday Barn, its employees, owners/agents responsible for any injuries or damages, which may result by reason of not seeking such veterinary care.

Owner represents that, to the best of Owner's knowledge, the dog(s) named above have never bitten or otherwise attacked any person or any other dog, and that the Owner has no reason to believe that Owner's dog(s) will do so in the future.

Owner agrees to hold Camp Holiday Barn, its employees, owners and/or agents, harmless from any and all claims asserted by or on behalf of any owner of any other dog which may be injured or damaged by reason of the action of Owner's dog(s).
